The Commission wrapped up a productive meeting in Spokane that included presentations, work sessions and some time outdoors. Here's what we covered.

### **COMMISSION MEETING**

#### Item E-1: Financial update

Director of Administrative services, Laura Holmes, provided an update about the Parks finances and budget (spoiler alert: overall it is looking good). We collected \$10.4 million more than was projected this biennium. The Discover Pass is the largest source of earned revenue, followed by camping.

#### Item E-2: Legislative update

Government Relations Director, Owen Rowe, shared an update about the 2023 legislative session. He and his team reviewed over 3,000 bills! Overall, things are looking good for our agency this year. We will know the final budget at the end of the week when session ends on April 23.

#### **Diversity, Equity and Inclusion (DEI) Update**

DEI Manager, Melinda Posner, shared progress being made in our agency's DEI efforts. The Pro-Equity Anti-Racism (PEAR) team has officially formed and is set to meet for the first time soon. We will also be rolling out a new DEI training later this year, along with all other state agencies. In partnership with the Washington Trails Association, we wrapped up another successful round of the Emerging Leaders Program.

#### No Child Left Inside (NCLI) grant evaluation update

We heard a second great presentation from Melinda Posner about the NCLI program. We're close to selecting another batch of grant recipients from a fantastic pool of diverse groups around the state. Since it's inception, this program has served around 135,000 kids and youth in WA and provided them more than 4.6 million hours in the great outdoors!

#### **Tribal Relations update**

Our agency Director for Tribal Relations, Jenna Bowman, gave a powerful presentation about her work so far. Jenna started with a message about how stories have the ability to connect to each other. She also shared an update on a survey she conducted with agency staff and discussed the difference between Big "C" Consultation and little "c" communication with tribes. She also highlighted the importance of both Tribal and Indigenous Sovereignty.

#### **Restoration project update**

Natural Resources Program Manager, Dr. Andrea Thorpe, presented an overview of major restoration projects currently underway. These include projects at Ragged Ridge Natural Area Preserve, Jones Island in the San Juans and habitat restoration for the Western Snowy Plover out on the coast. Did you know deer are good swimmers? That's why you find large populations on islands like Jones.
