
JANUARY COMMISSION MEETING RECAP

Item E-1: Financial update

Administrative Services Director Laura Holmes delivered <u>a report</u> on the status of:

- State Parks' 2021-23 biennium operating and capital budget expenditures,
- Parks Renewal and Stewardship Account (PRSA) revenue, and
- Agency comparison to the Governor's Budget for Fiscal Year 2023 Supplemental and the 2023-25 biennial budget.

Item E-2: 2023 Director's Performance Agreement and 2022 Performance Evaluation- Requested Action

The Commission was asked to adopt the 2023 Director's Performance Agreement, which includes the 2023 Commission Priorities.

It was also asked to document their conclusion that the Director performed satisfactorily in 2022, and that a meaningful evaluation process was used to reach this conclusion.

Life Saving Award

Thanks to the calm and quick action of Ranger Ben Martin, a woman who fell 12 feet from a cliff in Ike Kinswa State Park is alive and recovering from her injuries. Ranger Martin was first on the scene and was able to carefully pull the woman to safety from the rocks and water where she was unable to move on her own.

In another incident, Ranger Martin discovered the husband of a Senior Park Aide unconscious in his truck. He immediately recognized the signs of a diabetic episode. Ranger Martin was able to wake the man enough to ensure he was still breathing. Then he quickly called for someone to bring sugary liquids and snacks to get his blood sugar back up while an ambulance was called. The man was stabilized and transported to the hospital for treatment.

Parks is thrilled to <u>welcome Ali Raad to the Commission</u>. Raad is a first-generation immigrant from Lebanon and has lived in Thurston County since 1982. He is a civil engineer and began his career with the Washington State Military Department. He went on to work for the Washington Department of Transportation and the Washington Department of Ecology. Raad retired from state work in 2002 and now serves as the owner and president of Raad Properties.

Raad and his wife Sandra are parents to three children who graduated from the Olympia School District. They are the proud grandparents of five grandchildren. In his spare time, Raad enjoys taking nature walks and traveling with his wife.

Raad's term runs through Dec. 31, 2028. He takes the seat vacated by former Commissioner Steve Milner, whose term ended in Dec. 31, 2022.

New Commission Officers

The Commission elected new officers to serve for 2023 during its January meeting. The new chair of the commission is Ken Bounds, who replaces former chair Mark O. Brown. Commissioner Bounds previously served as vice chair of the commission. Commissioner Sophia Danenberg, former secretary, was elected into the vice chair position. Commissioner Laurie Connelly was elected to fill the vacated secretary seat.

WORK SESSION PRESENTATIONS

Governor Jay Inslee visits the Commission

The seven-member State Parks and Recreation Commission is appointed by the Governor, and the Commission usually schedules in-person meetings with the Governor during their January meetings in the Olympia area. For the last couple of years, these in-person meetings were not possible because of the pandemic. At the Commission's Work Session on Wednesday, these annual in-person meetings resumed and Governor Inslee attended as a special guest to discuss successes and challenges over the last couple of years at the park system.

Governor Inslee has been a strong advocate for the importance of public lands and outdoor recreation and has sought increased budget support of State Parks over his tenure. The Governor began the conversation with a discussion of his plan to increase housing for people experiencing homelessness and that he is not supportive of people using public parks for housing. Additionally, the Governor and Commission celebrated some of the recent capital budget successes with the completion of the Renslow Trestle, the Beverly Bridge, and the Tekoa trestle on the Palouse to Cascades Trail. The Governor also reflected on his visit to the grand reopening of the Goldendale Observatory in April and the ongoing development of the Nisqually State Park with the Nisqually Indian Tribe.
