Item E-1: Proposed 2025 Regular Meeting Schedule for the Washington State Parks and Recreation Commission – Requested Action

EXECUTIVE SUMMARY: This item asks the Washington State Parks and Recreation Commission to approve the dates and locations for the 2025 year and delegate to the Director and/or their designee, the authority to adjust the meeting locations in consultation with the Commission Executive Committee. This item advances the Commission's strategic goal: "Demonstrating that all Washingtonians benefit from their state parks".

SIGNIFICANT BACKGROUND INFORMATION:

Commission meetings are conducted in different geographic locations across the state to enable citizens to address their suggestions and concerns to the Commission. It is the Commission's intent to be visible and responsive to issues in different areas motivated by weather, population, location and types of recreational and natural resource issues. It is also the Commissioners intent to comply with direction from the Governor, the Legislature, and the public to be fiscally prudent and responsible.

The Commission Executive Committee and staff are recommending four in-person meetings, four virtual one day meetings, and the December annual planning meeting for 2025.
