- 14. Provide a brief summary of the 2024-2025 season to include:
  - a) A description of an average education/enforcement day and participation in safety training classes, local grooming council meetings, area trail council meetings, etc.

The Warden and/or DNR police starts the morning by driving to one of the two sno-parks. They conduct a road conditions check, letting the Mount Tahoma Trails Association operator know if plowing needs to be done. Then they go through the parking lots and start checking that all vehicles have sno-park passes. If a vehicle doesn't have a pass, they will leave a warning notice. They talk with people arriving to the parking lots, and answer any questions they have about the area. They help notify arriving visitors of how much parking remains at the lots. They repeat this series of actions at the second of the two sno-parks. Both the Warden and DNR Police takes all required DNR classes and safety trainings. The Warden or DNR Police is on site for any permitted recreation events or emergencies that occur in the project area. They also attend the Mount Tahoma Trails Association board meetings to foster communication with the non-profit that assists in managing the Mount Tahoma Trails System

b) Describe your complaint process (how are they recorded and tracked), the number and kind of complaints received, recurring themes and issues, and any known conflict between user groups.

Complaints make their way to our South Puget Sound Region headquarters via telephone or email. The complaints are then routed to our Recreation Manager for documentation and response. Our Region received no documented complaints this season from the public regarding the sno-parks or snow trail system

14. How is on the trail enforcement provided? What would you need to make on the trail enforcement more effective?

Trail enforcement is done via snow shoe, ski or by tracked UTV (If needed). This year we did not use the tracked UTV. The enforcement was mainly done by snow shoe/ski into the trail system

15. How is Sno-Park enforcement provided? What would you need to make Sno-Park enforcement more effective? Both the Warden and DNR Police have a State issued DNR truck with 4WD to get to the sno-parks. Upon arrival they can visually check the passes on vehicles, and give any information to the public in the area. The Warden is able to provide visitors with useful information about the conditions of the roads, snoparks, and ski trails prior to embarking on their trip. While the DNR Police have full authority to complete warden tasks and ability to arrest, or write greater tickets. These sno-parks are highly frequented by new visitors, so being able to provide them with information about the area's use is highly beneficial to other users, the land manager, and volunteer ski patrol. The Warden would also be able to provide information about local goods and services that may be needed by visitors. The Warden and DNR Police are responsible for enforcing sno-park pass compliance through a combination of verbal warnings, written warnings, and citations. Pass enforcement ensures that non-pass holding visitors are not taking up limited space in the sno-parks that a valid pass holding visitor could use. The Warden will have the option to give non-compliant users the opportunity to purchase a pass in lieu of giving them an infraction. If users do not follow up with the Warden showing proof of purchase of a pass, then the Warden can issue an infraction through the mail. This strategy of dealing with pass enforcement has been used in other DNR landscapes, and has lead to increased pass purchases, and thus brings in more funding for the sno-park program

The purpose of RCW 4.24.200 and 4.24.210 is to encourage owners or others in lawful possession and control of land and water areas or channels to make them available to the public for recreational purposes by limiting their liability toward persons entering thereon and toward persons who may be injured or otherwise damaged by the acts or omissions of persons entering thereon.

## Liability of owners or others in possession of land and water areas for injuries to recreation users—Known dangerous artificial latent conditions—Other limitations

- (1) Except as otherwise provided in subsection (3) or (4) of this section, any public or private landowners, hydroelectric project owners, or others in lawful possession and control of any lands whether designated resource, rural, or urban, or water areas or channels and lands adjacent to such areas or channels, who allow members of the public to use them for the purposes of outdoor recreation, which term includes, but is not limited to, the cutting, gathering, and removing of firewood by private persons for their personal use without purchasing the firewood from the landowner, hunting, fishing, camping, picnicking, swimming, hiking, bicycling, skateboarding or other non-motorized wheel-based activities, aviation activities including, but not limited to, the operation of airplanes, ultra-light airplanes, hang gliders, parachutes, and paragliders, rock climbing, the riding of horses or other animals, clam digging, pleasure driving of off-road vehicles, snowmobiles, and other vehicles, boating, kayaking, canoeing, rafting, nature study, winter or water sports, viewing or enjoying historical, archaeological, scenic, or scientific sites, without charging a fee of any kind therefor, shall not be liable for unintentional injuries to such users.
- (2) Except as otherwise provided in subsection (3) or (4) of this section, any public or private landowner or others in lawful possession and control of any lands whether rural or urban, or water areas or channels and lands adjacent to such areas or channels, who offer or allow such land to be used for purposes of a fish or wildlife cooperative project, or allow access to such land for cleanup of litter or other solid waste, shall not be liable for unintentional injuries to any volunteer group or to any other users.
- (3) Any public or private landowner, or others in lawful possession and control of the land, may charge an administrative fee of up to twenty-five dollars for the cutting, gathering, and removing of firewood from the land.
- (4)(a) Nothing in this section shall prevent the liability of a landowner or others in lawful possession and control for injuries sustained to users by reason of a known dangerous artificial latent condition for which warning signs have not been conspicuously posted.
- (i) A fixed anchor used in rock climbing and put in place by someone other than a landowner is not a known dangerous artificial latent condition and a landowner under subsection (1) of this section shall not be liable for unintentional injuries resulting from the condition or use of such an anchor.

- (ii) Releasing water or flows and making waterways or channels available for kayaking, canoeing, or rafting purposes pursuant to and in substantial compliance with a hydroelectric license issued by the federal energy regulatory commission, and making adjacent lands available for purposes of allowing viewing of such activities, does not create a known dangerous artificial latent condition and hydroelectric project owners under subsection (1) of this section shall not be liable for unintentional injuries to the recreational users and observers resulting from such releases and activities.
- (b) Nothing in RCW  $\underline{4.24.200}$  and this section limits or expands in any way the doctrine of attractive nuisance.
- (c) Usage by members of the public, volunteer groups, or other users is permissive and does not support any claim of adverse possession.
  - (5) For purposes of this section, the following are not fees:
- (a) A license or permit issued for statewide use under authority of chapter <u>79A.05</u> RCW or Title 77 RCW;
  - (b) A pass or permit issued under RCW 79A.80.020, 79A.80.030, or 79A.80.040;
- (c) A daily charge not to exceed twenty dollars per person, per day, for access to a publicly owned ORV sports park, as defined in RCW <u>46.09.310</u>, or other public facility accessed by a highway, street, or nonhighway road for the purposes of off-road vehicle use; and
- (d) Payments to landowners for public access from state, local, or nonprofit organizations established under department of fish and wildlife cooperative public access agreements if the landowner does not charge a fee to access the land subject to the cooperative agreement.

#### To Whom It May Concern:

The Mount Tahoma Trails Association has had a partnership since 1990 providing a year around recreational trail system for public use. This system is comprised of 50+ miles of winter recreation trail and 25 miles of summer recreation trail. Four huts provide overnight use for up to 42 people. In the winter MTTA conducts snow removal services to provide access to three state snow parks, as well as trail grooming. A very important part of the proper operation of this system is the official presence of an Education and Enforcement Warden.

We support the request for DNR's non-motorized Sno-Park project application - 92 Road and 1 Road Sno-Parks: Education and Enforcement. This grant will provide funding for an Education and Enforcement Warden, who will provide public information, education, and enforcement during winter months to Sno-Park users in both the Elbe Hills and Tahoma State Forests. This grant will help to improve stewardship, sustainability, information, interaction, education, and enforcement of public recreation use in the Elbe Hills and Tahoma State Forests. The Education and Enforcement Warden will be a great partner for MTTA, while keeping visitors safe and improving funds to the Sno-Parks.

\$ According to grooming logs sent to the Commission, grooming the Salmon Ridge Sno-Park trails requires 6.5 hours of grooming and 1.5 hours for Move-in/Lowboy Trucking -- (IHC 8100 Ramp). The current billing for this is \$1,582.50 each grooming day. Grooming once a week this past season was done 18.75 times with Sno-Park funds and 1.25 times with the ski club's NRTP grant money. This totals to \$30,067.50. This supplemental request if for \$30,067.00 so there will be twice a week grooming which would include Hannagen Pass Rd.

2) Please give a thorough description of the intended purpose of the proposed funding, including location, and affected Sno-Parks and trail systems.

This proposal is a supplemental funding request for \$30,067.00 to cover the grooming costs for twice weekly grooming of the Salmon Ridge Trail system for the 16 week season. Salmon Ridge Sno-Park is located 46.5 miles NE of Bellingham off the Mt. Baker Hwy (SR 542). Several years ago NNSC requested supplemental funding in order to have twice weekly grooming. The funding happended but grooming expenses still relegated the grooming to only once a week. Additionally, Hannegan Pass Road, THE ONLY 'DOG FRIENDLY' SKI TRAIL, HAS NOT BEEN GRROMED FOR TWO YEARS. Judging by the hours on the billings to the Commission, there is not enough time to include Hannegan Pass road in grooming under the alloted amount of funds. Also, for two seasons in a row, the on-going funding ran out before the end of the ski season. In this past 2022-23 season some NRTP grant funds had to be used for grooming to complete the month of March.

- a. Does your total request factor in the potential need for Snow Removal, Grooming, Sanitation, Education, Enforcement and possible need for dirt/land work?
  Yes. Snow removal, sanitation, education and enforcement are already coved by the on-going Sno-Park grooming grant for the once per week grooming. This request is for additional grooming funds to
- 3) What is the estimated target audience (snowmobilers, dog mushers, cross country skiers, snowshoers, others) and what percentage do you anticipate each use at? The target audience would be cross country skiers and skijorers evenly divided at 48% skiers, 48% snowshoers and 2% skijorers.
- 4) Why is this project essential? (New or expanded area, local economic impacts, recreational demands)

Salmon Ridge Trail System is a vital winter recreation site maintained by the Nooksack Nordic Ski Club whose members donated 718.5 hours (a value of \$13,174.00) of volunteer work in the 2022-23 season and contributed the equivalent of \$6,615.49 dollars in mileage for a total of \$19,789.39 of volunteer value. In 2021, the club provided the USFS with a gate that improved the Salmon Ridge Trail system at the entrance to the Mom's section, improving the groomer's ease of access for trail entrance and exit. This was funded strickly through a donation. Since the 1980's the USFS has had a great working relationship with Nooksack Nordic Ski Club and all the volunteer work this club has done to educate the public and maintain the trail system. It is the only tracked and groomed cross country ski area north of Stevens Pass. The Commission is well aware of the rise in Winter Recreation use as a result of Covid and maintaining this ski area with twice a week grooming will continue to help diversify the places for winter recreation and prevent overcrowding.

Salmon Ridge Sno-Park has separate but integrated snowshoe trails, but because it is an open access Sno-Park, many snowshoers walk on the groomed surface of the ski trails and damage them. With no grooming of the dog friendly trial, dogs are being brought to the groomed trails. Without the funds to groom the trails twice weekly to continually maintain the integrity of the trail system for skiers, the area becomes hazardous for skiers. There are hills in this trail system and after a weekend of snowshoe or dog damage, the groomed trails, especially any hill area, become dangerous for skiers. With such high snowshoe useage, the twice weekly grooming is desperately needed. No grooming on Hannegan Pass road has already brought dogs onto groomed trails. Declining conditions with the once a week grooming would result in unsatisfied skiers and declining use of this trail system causing people to go to other already crowded ski areas.

5) Briefly describe the recreational benefits of the proposal. How will this funding improve the recreational experience of visitors? What types of recreational uses will be enhanced? A great example of the benefits (recreational to the users and financial to businesses) is that NNSC works in concert with the other entities and the City of Bellingham with their recreational outing progam on our Ambassador Days, providing cheer, hot chocolate, education about and maps of trails, types of skis, information on need for, as well as providing the sale of, Sno-Park permits, snowshoeing and even some free skiing instruction that day. The users provide their own equipment thus benefiting local businesses (ski and restaurant) and they get a great recreational experience. Twice a week grooming makes for happier and safer skiers - providing a great surface for their recreational outing/exercise and a much safer surface for less injury from snowshie or dog damage. The completed Connector trail that links White Salmon to Salmon Ridge has accomplished a couple of things. 1. it has opened up possibilities for White Salmon road to be in consideration of a future Sno-Park revenue source for the Commission and, 2. It provides White Salmon road grooming, to back country sking, to Salmon Ridge grooming trail experience. Tired skiers coming down to Salmon Ridge from White Salmon road need the twice grooming type trail for a safe experience. 

2) Please give a thorough description of the intended purpose of the proposed funding, including location, and affected Sno-Parks and trail systems.

The Highlands Nordic Ski Club would like to purchase a rescue sled to be used for emergency transportation of incapacitated skiers. The rescue sled would be towed behind one of the grooming snowmobiles by a volunteer operator. The ski club does the grooming and maintains a cadre of operators who utilize a system of cell phones, Forest Service radios, and satellite communications to rapidly respond to emergency situations. Working with local neighbors, ski club members, the Okanogan County Sheriff's Department Search and Rescue, and the Forest Service, we could respond quickly and efficiently. Okanogan County Search and Rescue is not usually a rapid response program. The ski club could significantly reduce response time to emergency situations at the Highlands Sno-Park.

a. Does your total request factor in the potential need for Snow Removal, Grooming, Sanitation, Education, Enforcement and possible need for dirt/land work?

Yes, the request would be an important piece of the Safety Program at the Highlands Sno-Park, but require no additional snow plowing, sanitation, or enforcement. Local neighbors can respond very quickly to emergencies. The groomers all have Forest Service Radios which can communicate with local county/state/federal agencies, and satellite communications to respond to emergency situations.

3) What is the estimated target audience (snowmobilers, dog mushers, cross country skiers, snowshoers, others) and what percentage do you anticipate each use at?

The Highlands Sno-Park serves several user groups such as; Nordic Skiers(80%), Snowshoers(12%), Snowmobilers(2%), Skijorers(3%), and others(3%)-Fat tire bikers, bird watchers, and folks out for a winter walk. All user groups would benefit from the increased safety of a rescue sled.

4) Why is this project essential? (New or expanded area, local economic impacts, recreational demands)

Recreational demands are growing at the Highlands Sno-Park and the ability to respond to emergency situations is essential. Increased public visits at the Highlands Sno-Park requires increased safety precautions by the ski club. Several years ago a skier injured her knee late in the afternoon and wasn't able to ski out. Volunteers were able to bring her out on a snowmobile, but had she been unable to ride on the back, the situation would have been much more complex. A rescue sled will give us away to quickly evacuate people with a wide array of injuries

5) Briefly describe the recreational benefits of the proposal. How will this funding improve the recreational experience of visitors? What types of recreational uses will be enhanced?

Winter Recreation inherently requires an emphasis on safety precautions. A rescue sled would benefit all users. Public confidence and safety awareness will increase with the addition of a rescue sled at the Highlands. The ski club tries to encourage local residents to get outdoors and enjoy the Winter and the rescue sled could help.

I am writing in support of the Highlands Nordic Ski Club receiving funds to purchase a rescue sled for their Nordic trail system near Tonasket, WA.

I believe this would be a great resource and provide added safety measures for trail users. As part of the Okanogan County Sheriff's Office Search and Rescue team, I've used similar rescue sleds during SAR missions and they are an efficient and easy-to-use tool for extricating people quickly.

Okanogan County Search and Rescue does own one of these sleds, but it would be quite time consuming to transport the necessary equipment to the Highlands area in the event of an injury or rescue, as we store all of that gear either near Winthrop or Okanogan. In the case of a serious injury or in cold temperatures, time is of the essence and having a rescue sled staged on-site could make a huge difference.

The Highlands Nordic Ski Club provides excellent recreation opportunities for a rural, somewhat isolated area, and I believe their ability to purchase a rescue sled would greatly add to the public safety resources available in the area.

This is a third year request for the Stemilt Basin Non-Motorized Sno-Park located near the intersection of the Orr Creek Roak and the Stemilt Creek Road. The request is primarily for snow removal/plowing. About 100 yards of the Orr Creek Road must be plowed from the county road (Stemilt Creek Road) to reach a small plowed parking lot capable of parking about 8 cars on property owned by Washington Department of Fish and Wildlife (WDFW). WDFW has granted permission for this lot to be plowed for winter, non-motorized visitors coming to snowshoe, cross-country ski, walk etc. Some of the funds will also be used for the

a. Does your total request factor in the potential need for Snow Removal, Grooming, Sanitation, Education, Enforcement and possible need for dirt/land work?

The 'trails' beyond the plowed parking area are gated forest roads that will NOT be machine groomed but 'groomed' through use. As such, none of the proposed funding would be used for grooming.

3) What is the estimated target audience (snowmobilers, dog mushers, cross country skiers, snowshoers, others) and what percentage do you anticipate each use at?

Snowshoers 30%, cross-country skiers 20%, dog walkers and winter walkers 25%, family snowplay 15%, backcountry skiers 10%.

4) Why is this project essential? (New or expanded area, local economic impacts, recreational demands)

Wenatchee has an active outdoor populace. Many people move here or choose to stay here because of our immediate access to the outdoors. Quick access to the outdoors is especially true of our snow-free months when the surrounding foothills trails accommodate hikers, runners, and mountain bikers. Most of these foothills trails, however, close between December 1 and March 30 to help the mule deer wintering here. The proposed Sno-Park would help fill the void left by the winter closure of our foothills trails and would be well received by our active populace.

5) Briefly describe the recreational benefits of the proposal. How will this funding improve the recreational experience of visitors? What types of recreational uses will be enhanced?

The attraction of this particular Sno-Park is its proximity to Wenatchee AND its relatively gentle topography. This is a place where beginner snowshoers, beginner backcountry skiers, intermediate cross-country skiers, parents wanting to play in the snow with their children can all come to safely recreate. The gentle topography helps beginners learn how to use the awkward boards strapped to their feet, and there is virtually no avalanche hazard in and around the proposed parking area. None of this winter use will happen during a snowy year because there is simply no place to park. The purpose of this proposal, then, is to provide parking so winter recreationalist can gain access to this area.

Thank you for your consideration.





#### Attachment B

#### OKANOGAN-WENATCHEE NATIONAL FOREST ROAD RULES

This document has been prepared to alert Forest road users of the numerous Federal and State requirements governing the use of National Forest System roads. The following Road Use Rules summarize the most important regulations and restrictions governing use of Forest Service roads:

- 1. It is prohibited to possess or operate a motor vehicle on National Forest System roads other than in accordance with the designations identified on a motor vehicle use map, provided that some vehicles and uses are exempted from this prohibition as identified in 36 CFR 261.13 Motor vehicle use including, (h) motor vehicle use that is specifically authorized under a written authorization issued under Federal law or regulations.
- 2. All Forest roads are subject to short-term traffic restrictions or closures due to weather and subgrade condition, user safety, or when necessary to permit reconstruction and maintenance, or to provide long-term closures to comply with adjacent land management objectives. The commercial use of any Forest Service road will be authorized by permit only.
- 3. Damaging or leaving in a damaged condition, any road, road segment or traffic control device is prohibited. Reference 36 CFR 261.12(c). Damage is exclusive of ordinary wear requiring road maintenance as described in contracts, permits, or road maintenance agreements.

Following are examples of road damage:

- a. Destruction of road prism including ditches, surfacing subgrade, base course, backslopes or fillslopes.
- b. Deforming or breaking bridge rails or bridge curbing, guardrails, culverts, signs or signposts, markers or other structures.
- c. Lug or cleat marks on a bridge or road surface that is constructed of asphalt, concrete, wood, or metal.
- 4. The provisions of the Revised Code of Washington, Chapter 46.61(RCW), relating to the operations of motor vehicles, are applicable to all Forest Service roads on the Okanogan-Wenatchee National Forest and are enforceable by Federal, State or County law officers.
- 5. The load, weight, height, length, and width limitations of vehicles on National Forest roads shall be in accordance with Section 46.44 (RCW) of the motor vehicle laws of the State of Washington and will be enforced under Federal Regulations. Exceptions to this rule will occur only when signs giving notice thereof have been posted on the road or when a specific written authorization, permit, or order under 261.54(d) provides otherwise.
  - <u>Some bridges</u> are not structurally adequate to handle normal highway loadings cited in Section 46.44(RCW). These bridges are posted with signs which give the legal notice of the reduced limits. Refer to 36 CFR 261.12(a). <u>Application for overload</u> or <u>variance permits</u> on roads or bridges must be made through the District Ranger with an adequate time allowance for processing. A10 to 15 day period is usually required to process a Permit Application.
- 6. Commercial use will be permitted on any National Forest System road only when authorized by permit or written authorization such as, a contract, easement, deed, or other written agreement. All commercial-use requests will be initiated through the District Ranger, 36 CFR 261.54(c).
- 7. Commercial use of a National Forest System Road by any permittee or contractor will be suspended when such use will cause damage to the roads or National Forest Resources, when such use will result in unsafe conditions to others or when the road is in an unsafe condition. Such suspension shall be effective when the commercial user is notified in writing or by road closures posted on the road per Regulation 36 CFR 261.54(b).
- 8. Snowplowing will only be permitted by specific provision in each permit, contract provision, or other written agreement signed by the District Ranger.

Some roads on the Okanogan-Wenatchee National Forest are not available for winter commercial use because of recreational use or other conflicts. Prospective users should contact the District Ranger as to whether snow plowing will be authorized during the period of the permit or contract.

- 9. Written permission to block a road may be issued only by District Ranger, or Contracting Officer. Unless otherwise provided in a contract, permit, or agreement, no road shall be blocked by the placing of any vehicle or other object upon it in a manner that is an impediment or safety hazard, or conflicts with other users. Reference 36 CFR 261.12(d). Following are examples of an impediment:
  - a. Slow moving logging, construction, or road maintenance equipment operated without posting proper warning signs.
  - b. Logging slash or other debris deposited or left in a roadway or turnouts.
  - c. Logs yarded or decked on the road travelway or turnouts.
  - d. Abandonment of vehicles or other personal property on any Forest Service road.
- 10. Posting of notices, messages or the installation of other signing, including citizen band radio check point signs must be approved by the District Ranger.
- 11. Written permission is required to use a motor vehicle on any National Forest System Road that is not designated on the Motor Vehicle Use Map for motor vehicle use including the class of vehicles and time of year. All regulations and restrictions shown on the Motor Vehicle Use Map must be followed unless approved by the District Ranger in a written special use authorization, contract or operating plan prior to use.
- 12. Lugged traction devices will allowed on asphalt surfaced roads by permit only, reference 36 CFR 261.12(c).

#### ROAD MAINTENANCE REQUIREMENTS AND SPECIFICATIONS, SNOW PLOWING REQUIREMENTS AND SPECIFICATIONS.

The following road maintenance activities are authorized subject to the following requirements and specifications.

Blading

**Ditch Maintenance** 

Removal And End Haul of Materials

**Drainage Structure Maintenance** 

**Cutting Roadway Vegetation** 

Spot surfacing

#### **BLADING**

#### Description

This work consists of surface blading the traveled way to a condition that facilitates traffic and provides proper drainage. Blading includes shaping the crown or slope of traveled way, berms, and drainage dips in accordance with this specification.

Maintenance Requirements

#### A. General

- 1. Blade and shape the existing traveled way and shoulders, including turnouts, to produce a surface which is uniform, consistent to grade, and crowned or cross- sloped as indicated by the character of the existing surface, to at least ½ inch per 1 foot of width, but not more than ¾ inch per 1 foot of width. Thoroughly loosen surfacing material to no less than 2 inches depth or the depth of potholes or corrugations. Scarification to facilitate cutting to the full depth of potholes or corrugations may be elected, but will be considered incidental to blading. Do not scarify to a depth that will cause contamination of road surfacing.
- 2. Apply water during blading when sufficient moisture is not present to prevent road surfacing material segregation.
- Shape existing native rock or aggregate surfaced drainage dips to divert surface runoff to existing outlet devices, ditches, or discharge locations.
- 4. Establish a blading pattern which provides a uniform driving surface, retains the surfacing on the roadbed, and provides a thorough mixing of the materials within the completed surface width. Upon final blading, no disturbed rock shall protrude more than 2 inches above the adjacent surface unless otherwise provided in the contract. Remove and place outside the roadbed, material not meeting this dimension so as not to obstruct drainage ways or structures. This material may be scattered off the roadbed if there is free drainage.

#### **DITCH MAINTENANCE**

#### Description

This Section provides for routine maintenance of various types of ditches to provide a waterway which is unobstructed.

#### Maintenance Requirements

- A. Maintain ditches by removing rock, soil, wood, and other materials. Maintained ditches shall function to meet the intent of the original design.
- Undercutting backslopes during debris removal operations is not permitted.
- C. Do not blend material from ditch cleaning operations into aggregate surfaced roads. Do not blade material across aggregate or bituminous surfaced roads, unless approved in writing by the Authorizing Forest Service Official.
- Haul excess material to a designated waste area. Remove excess materials temporarily stored on the ditch slope or edge
  of the shoulder daily.
- E. Remove limbs and wood chunks in excess of 12 inches in length or 3 inches in diameter from ditches and place outside the roadway.
- F. Shape lead-off ditches to drain away from the traveled way.

#### Removal and End Haul of Materials

#### Description

Work consists of specified or ordered loading, hauling, and placing of slide, slough, or excess materials such as rock, soil, vegetation, and other materials to designated disposal sites.

#### Maintenance Requirements

A. Dispose of material at designated sites as directed by authorized Forest Service personnel.

Reshape slopes as nearly as practical to original conditions by equipment operating from the road surface. Reshaping of roadside ditches in slide areas shall be in accordance with drainage structure specifications.

- B. When approved by authorized Forest Service personnel, fill slumps by compacting selected materials into roadway depressions.
- C. Place all materials in disposal sites by one or both of the following methods as directed by authorized FS personnel.
  - 1. Side Casting and End Dumping. Material may be placed by side casting and end dumping. Where materials include large rocks, provide a solid fill by working smaller pieces and fines into voids. Shape the finished surfaces to drain.
  - Layer Placement Step or roughen surfaces on which materials are to be placed prior to placing any material. Place materials
    in approximately horizontal layers no more than 12 inches thick. Compact each layer by operating hauling and spreading
    equipment over the full width of each layer.

#### **DRAINAGE STRUCTURE MAINTENANCE**

Description

This work consists of cleaning and reconditioning culverts and other drainage structures.

Maintenance Requirements

- Clean drainage structures, inlet structures, culverts, catch basins, and outlet channels. Clean catch basins by removing the material.
- B. Clean the transition from the ditch line to the catch basin a distance of 10 feet from the catch basin. Clean outlet channels and lead-off ditches a distance of 6 feet. Remove and place debris and vegetation so as to not enter the channel or ditch, or obstruct traffic. Haul debris and vegetation to a designated disposal area.
- C. Hydraulic flushing of drainage structures is not allowed unless otherwise authorized.

#### **CUTTING ROADWAY VEGETATION**

#### Description

This work consists of cutting all vegetative growth, including trees and other vegetation less than 4 inches in diameter measured 6 inches above the ground, on roadway surfaces and roadsides.

Maintenance Requirements

#### General

- 1. Brush cutting shall not exceed the following limits: 4' beyond the edge of the roadway surface. Roadway surface includes ditches and pullouts.
- 2. Vegetative material less than 4" in diameter breast height (dbh) is permitted for removal. Removal of material greater than 4" dbh may be permitted on a case by case basis. Written authorization must be obtained prior to such removal.
- 3. Cut brush, trees, and other vegetation within authorized areas treated to a maximum height of 6 inches above the ground surface or obstruction such as rocks or existing stumps. For trees greater than 4" dbh, remove all limbs which extend over the roadbed, to a height of 14 feet above the traveled way surface elevation. Limb branches no greater than 4" from tree trunks.
- 4. Items to remain will be designated on the ground by authorized FS personnel.
- 5. Disposal. Lop and scatter: Cut vegetative material in 4 foot lengths or less and widely scatter all displaced vegetative material on the downhill side of the roadway, away from the road surface and road drainage structures such as culverts and ditches. Vegetative material should be in contact with the ground.
- 6. Work may be performed either by hand or mechanically unless otherwise specified. Self-propelled equipment is not allowed on cut and fill slopes or in ditches.
- Correct damage to trunks of standing trees caused by Permittee's activities either by treatment with a commercial nursery sealer or by removing the tree, as directed.
- 8. Commence work at the edge of the traveled way and proceed away from the road centerline.

#### **WATER SUPPLY AND WATERING**

#### Description

This work consists of providing facilities to furnish an adequate water supply, hauling and applying water.

#### Materials

The Permittee is responsible to obtain the rights for water used, including any cost for royalties involved.

#### ADDITIONAL RESTRICTIONS:

Pumping, damming or other activities that dewater any streams is not allowed. Maintain the following discharge rates on all streams:

- A. Do not reduce flows to less than 50% of the flow occurring at the time of withdrawal; in no case will flows be reduced to less than 1.0 CFS (about 7.5 gallons/second).
- B. The designated water sources may require some work prior to their use. Such work may include cleaning ponded areas, installing temporary weirs or sandbags, pipe repair, pump installation, or other items appropriate to the Permittee's operations. Flowing streams may be temporarily sandbagged or a weir placed to pond water, provided a minimum flow is maintained. Obtain approval on improvements for sandbags or weirs prior to placement.

#### Equipment

- A. The Permittee shall utilize one of the following methods of screening on draft hoses used to withdraw water from any live flowing stream.
  - (1) Perforated Plate:

Screen openings shall not exceed 3/32 or 0.0938-inches.

- (2) Profile Bar Screen:
  - The narrowest dimension in the screen openings shall not exceed 0.0689-inches in the narrowest direction
- (3) Woven Wire Screen:

Screen openings shall not exceed 3/32 or 0.0938-inches in the narrow direction.

All methods shall be kept clean.

- B. An air gap or positive anti-siphon device shall be provided between the water source and the vehicle being loaded if the vehicle has been used for other than water haul, if the source is a domestic potable water supply, or the water is used for tank mixing with any other materials.
- C. Positive control of water application is required. Equipment shall provide uniform application of water without ponding or washing.

#### **SPOT SURFACING**

#### Description

This work consists of placing road surface aggregate. It includes preparing the area, furnishing, hauling, and placing all necessary materials and other work necessary to blend with the adjacent road cross section.

#### Materials

A. Materials furnished by the permittee or a commercial source must first be accepted by the government in writing before placement. Materials must be certified weed free.

#### Maintenance Requirements

- A. Thoroughly loosen the area to be spot surfaced to a minimum depth of 1 inch prior to placement of aggregate.
- B. Mixing and Placing
  - 1. When scheduled coincidentally with road blading, mix spot surfacing and existing aggregate with water until a uniform mixture is obtained prior to final shaping and compaction.
  - 2. Otherwise, spread the material on the prepared area in layers no more than 4" in depth. If more than one 1 layer is placed, shape and compact each layer before the succeeding layer is placed. Upon completion, the spot surfacing shall reasonably conform to the adjacent cross section and provide smooth transitions in the road profile.
  - 3. Compaction Method: Compact with equipment on the traveled way.

- 2) Please give a thorough description of the intended purpose of the proposed funding, including location, and affected Sno-Parks and trail systems.

This funding would support orchestrating a volunteer educational outreach program at 3 locations, 3 Saturdays per month, from December to March (beginning and end program dates vary with snowfall). The locations are Cabin Creek or Franklin Falls (depending on USFS staffing), Crystal Springs, and Gold Creek.

The purpose of this volunteer educational outreach effort is three-fold: to increase compliance with winter recreation passes and snowmobile registration, to encourage good etiquette and behavior on shared trail systems, and to provide information and orient new visitors. Increasing pass and sled registration compliance will increase funding available to the Winter Recreation Program.

We will recruit, train, and equip volunteers to visit these locations on Saturdays from 10am to 1pm for this end. Volunteers will be equipped with a branded vest and/or beanie, table, chairs, information pamphlets, hot cocoa (to give away to facilitate public engagements), and both season and day passes to sell. Volunteers will alternate between staffing the table and making active engagements around the trailhead, offering hot cocoa, selling passes, engaging visitors about good trail etiquette, and educating users on why purchasing passes and registering sleds is important – i.e. how they fund the winter recreation program and trail grooming. Volunteers will also be a touchpoint for information like trail routes, grooming, and regulation information. Passes can be purchased with cash or card, using square card readers. Volunteers will be Mountains to Sound Greenway volunteers, meaning that they will participate in this program under MTSG liability, sign up through MTSG portals, be coordinated by MTSG staff, and so on.

Volunteers will also gather useful data for State Parks: This will include the number of people at the trailheads, the number of contacts made, number of passes sold, type of recreation visitors engage in, etc.

2a. Does your total request factor in the potential need for Snow Removal, Grooming, Sanitation, Education, Enforcement and possible need for dirt/land work?

Yes, no extra grooming or maintenance needs to be done for this program.

3) What is the estimated target audience (snowmobilers, dog mushers, cross country skiers, snowshoers, others) and what percentage do you anticipate each use at?

The target audience encompasses all users, both motorized and non-motorized. The goal of this program is to be of use to both programs and facilitate partnerships between affinity groups.

We anticipate the percentage of different user groups to mimic who uses the trailheads. At Cabin Creek or Franklin Falls we expect exclusively nonmotorized users: mostly skiers and snowshoers. At Crystal Springs, we expect about 50/50 motorized and nonmotorized users, which include: skiers, snowmobilers, dog mushers, snowshoers, and even sledders/families looking for snow play. At Gold Creek we expect about 90% nonmotorized and 10% motorized users.

4) Why is this project essential? (New or expanded area, local economic impacts, recreational demands)

This program's goal is explicitly to engage volunteers in these user groups to increase pass and registration compliance in order to bring in more funding for the Winter Recreation Program, both for the motorized and nonmotorized programs.

5) Briefly describe the recreational benefits of the proposal. How will this funding improve the recreational experience of visitors? What types of recreational uses will be enhanced?

This program will help newer recreators get oriented with the winter recreation program and the trails system and reduce user conflict/bad trail etiquette that can sometimes impede grooming efforts (such as snowshoers walking on the xc ski tracks). Visitors will experience a welcoming presence, free hot cocoa and information, and better etiquette on shared trails systems. This program will also help maintain or grow funding for the Winter Recreation Program, which benefits users by keeping sno-parks open, groomed, and maintained, and hopefully can contribute to future recreation opportunity expansions.

Yes, specifically with customer experience, quality of life, resource protection, and resource management.

Visitors will be greeted by volunteers who care about the winter recreation program, who will offer hot cocoa, information, passes, and education about why passes are important to the winter rec program. In this way, volunteers are representing state parks and providing direct customer service.

This program will help raise funds via pass compliance and sled registrations that go directly back into the program, supporting the recreation activities that are so important for Washington residents during the winter. Our hope is to make participating in winter recreation a more accessible experience for newbies and to increase pass sales that fund the operations and maintenance that allow winter recreation to happen. Winter sports have a long history in Washington, and this program aids the preservation of that cultural history by 1) engaging folks in organizations that preserve this history and are a wealth of knowledge and 2) aiding the program's ability to provide access to areas through pass sales.

Aiding the program through pass sales supports visitor participation in winter sports and the recreation communities around it. The mere presence of volunteers discourages vandalism attempts and bad behavior at the trailheads. Additionally, because Crystal Springs Sno Park has ADA-inclusive facilities, volunteers can support inclusion for disabled visitors by providing education about the importance of access and adaptive sports, encourage advocating for expansion to other Sno Parks, and orient new visitors who use the infrastructure.

Yes, I have reached out and received responses from Peter Valaas, Emilie Blevens, and John Baranowski.

  - \$3,500. This is for additional funding to support grooming the Lake Keechelus Boat launch road (NF 9070-219) from berm near Hyak Sno Park to the USFS Keechelus Trailhead parking lot near the gate on Saturdays from January to the end of the grooming season. Estimated cost of \$3,500 for grooming by the Lake Easton State Park staff (full expenses for staff time and equipment operations). Note that the Lake Easton State Park have assisted in grooming this road under previous years' funding awards.
- 2) Please give a thorough description of the intended purpose of the proposed funding, including location, and affected Sno-Parks and trail systems.
  - This project is essential to building an expanded and more diverse nordic skiing/snowshoe/snow play experience for all citizens that use the Hyak Sno Park/Ironhorse Trail, one of the most popular in Washington state. The expansion will also help reduce user conflict by spreading out users on an expanded trail system where users can access multiple branch trails via a groomed route that connects to multi-use routes such as the Common Corridor, the High Horse Trail, and the Roaring Ridge Backcountry. This expansion will provide more inclusiveness especially on days when organizations run their programs at Hyak Sno-Park, including but not limited to Outdoors for All, REI Adventure Outings, The Mountaineers, Washington Alpine Club, Washington Ski Touring Club, and the Snoqualmie Nordic Club that maintains a warming hut on the expanded trail system. We believe that the user experience will be enhanced due to the ability to spread out onto new trails from the narrow and heavily used Ironhorse Trail.
- a. Does your total request factor in the potential need for Snow Removal, Grooming, Sanitation, Education, Enforcement and possible need for dirt/land work?

Yes, no additional expenses are required other than the cost associated with grooming that will be completed by Lake Easton State Park. Regular operations of the Hyak Sno-Park and the Palouse to Cascades Trails have been discussed with State Parks staff and they do not anticipate any additional costs. The return on investment for this project is unmatched as it only requires grooming hours with no additional expenses for a greatly expanded trail system in a highly desirable location. The SNC provides volunteers to maintain the trails, clean up trash, erect informational signage, and provide a warming hut in the Keechelus Trailhead parking lot located a half mile from Hyak Sno-Park.

- 3) What is the estimated target audience (snowmobilers, dog mushers, cross country skiers, snowshoers, others) and what percentage do you anticipate each use at?

  This will be a multi-use trail open to nordic skiers (40%), snowshoers (45%), backcountry skiers (10%), boot hikers for snowplay (5%), and possibly ice skaters and paragliders (<1%).
- 4) Why is this project essential? (New or expanded area, local economic impacts, recreational demands)
  - This project is essential for meeting the needs of a growing, diverse, and underserved population from several large metropolitan areas in Western WA (Seatte, Bellevue, Tacoma, etc.) seeking winter recreation in an environment where access and opportunities are shrinking. We believe this is a cost-effective and responsible way to increase infrastructure and provide additional opportunities for all users in the I-90 corridor who will be impacted by the pending closures of the Summit East Nordic lower trail system and the Gold Creek Ponds for recreational use, for example. Hence, we are initially requesting funding for grooming on Saturdays which are the busiest day of the week with regularly scheduled events by several outdoors organizations such as Outdoors for All, Central Cascades Recreation Association, The Mountaineers, Washington Ski Touring Club, and the Snoqualmie Nordic Club.
- 5) Briefly describe the recreational benefits of the proposal. How will this funding improve the recreational experience of visitors? What types of recreational uses will be enhanced? The Sno-Parks along I-90 are severely impacted by limited groomed trails for accessing scenic vistas, accessing backcountry areas, and for open spaces like what is afforded on the Lake Keechelus Boat Launch road. Granted it is less than a mile of grooming but even this distance limits many users from experiencing the scenic views of the Cascade Crest. We anticipate a large increase in demand due to the pending closure of the Gold Creek Ponds at Gold Creek Sno-Park and it is our goal to provide some mitigation for the loss of this extremely popular recreation area.

SNC held a conference call with John Ernster, Regional State Park Manager and Andrew Kerlee, State Park Ranger for Hyak and the Palouse to Cascades Trail to discuss the use of WA State Park property and any impacts to the adjacent property. They are in agreement to use the State Park property for access to the Boat Ramp Road at two locations where there are roadways connecting to the groomed Palouse to Cascades Trail. They supported the proposal to groom the Boat Launch Road and asked SNC to coordinate the grooming request with Joshua White, Lake Easton State Park Construction and Equipment Manager and the grooming program director.

There is no direct impact to residents of Hyak Estates or to residents on State Route 907. The Boat Launch road is bermed at the junction with the Hyak Sno-Park entrance in the winter so there is no vehicle traffic on this road when snow is present.

- 10) Describe what communications were conducted to obtain homeowners/housing developments/land owners support.
  - In prior years SNC has received Special Use Permits from the Mount Baker/Snoqualmie National Forest North Bend Ranger District. Steven Johnson, Nikolai Ferrell, and Brian McNeil provided letters of support for grooming the road. Since then, the management of the area has changed to the Wenatchee National Forest Cle Elum Ranger District. We are requesting Special Use Permits from staff in Cle Elum. SNC received Special Use Permits for grooming the road in 2024/25 from the Cle Elum Ranger District.
- 11) Are there any permitting or environmental review requirements associated with implementation of the proposal? (i.e. NEPA, SEPA, Environmental Assessment, Hydraulics Permit, Building Permit, etc.) There were no review requirements in prior years as the road is open to motor vehicle use by the public when not closed by snow for winter recreation. The road is a high standard, two lane with wide shoulders and pull outs, paved, with guard rails, and used to access the boat launch on Lake Keechelus when the road is open. The road would only be groomed after the snow depth reaches the standard of 24 inches on the ground unless State Parks obtains a lightweight grooming machine that would allow grooming with less snow depth. If equipment and staff are available the road surface can be rolled and packed with as little as six inches of snow cover. This helps preserve the snow and provides a safe surface for recreation.

No additional permits or environmental review is necessary under the guidelines of the US Forest Handbook (FSH 1909.15) Chapter 30 NEPA Categorical Exclusion, 36 CFR, 220.6 (d) (4) Repair of roads and maintenance of roads and trails.

We believe this funding proposal is consistent with the elements of the Winter Recreation Plan. It is our understanding that the mission of the Winter Recreation Program is to provide "a variety of snow-based winter recreation opportunities to the public while protecting natural and cultural resources." We also understand that the vision of the Winter Program is a "well managed and respected program that is effective and efficient in providing service that meets the demands of the public." Given this, we believe that as the demand for non motorized recreation in Washington State increases due to popularity and population growth there will be increased demand along I-90 for safe high quality groomed trails. We support the State Park Program as partners and by adding the additional grooming of the boat launch road we believe it will bring the program one step closer to meeting that anticipated demand. Last, we believe that with an additional groomed trail added to the Hyak Sno-Park this will help to disperse users across a wider area of varied terrain to help avoid user conflicts, reduce crowding, improve safety, and enhance the overall recreational experience of all outdoor winter recreationalists. All of these aspects support the Winter Recreation Program's Strategic Plan.
