Cama Beach Public Comments

September 11 – 19, 2024

We have loved staying at the Cama Beach cabins over the past 13 years. It is sad to see them go, but I support keeping the area closed. This has been requested by the local tribes and is also best from an environmental standpoint. Public day access would be great to offer while not re opening for overnight stays. ¹

My name is [x] and I've been enjoying Cama Beach Historical State Park since 2017, when I first started volunteering there for the Center for Wooden Boats. (Since the opening of the park in 2008, CWB has run the Boathouse and the Boat Shop, keeping the boat rental operation alive while teaching boat building and repair.) I'm writing to encourage you to do the maintenance and repair work necessary to restore the park to full operation.

If you've never been to Cama Beach, you should go. There's just no substitute for the jaw-dropping experience of walking down that hill and finding yourself in the 1930s; gazing across Saratoga Passage from the long, secluded beach and feeling yourself transported into the past.

During the summer of 2021 I managed the Cama Beach Boathouse for CWB, bunking in the Fire Truck Garage at night during my four-day work weeks. It gave me the opportunity to experience the park in all its glory. During the day we sent families and friends out on the water in rowboats and kayaks. In the evenings I watched while the families staying in the cabins enjoyed the wonders of the park: impromptu softball games and soccer matches, kids playing on the beach, family meals at picnic tables, and everyone watching the sunsets over the water. Such a joyful place!

In the simple, wooden cabins, tiny by today's standards, families found plenty of room to enjoy the togetherness and pleasures of their grandparents' generation. With no Wi-Fi and little or no cell service, people rediscovered how to have fun in the old-fashioned ways: playing board games, doing puzzles, reading a book, or going for a walk. Many families came back year after year to enjoy a one-of-a-kind, Pacific Northwest-style vacation. There was also lots to learn.

The Cama Beach Foundation presented programs on sea life, including tide pooling at low tides. Interpretive signs explained the history of the park, from its use for food gathering by Native Americans, as a logging camp, and finally as a boating and fishing resort. We ran Toy Boats sessions for kids, during which children built wooden model boats using real hand tools. And there's no substitute for being on the water in a small, human-powered boat to get in touch with the beauty and fragility of the marine environment and understand our rightful place there.

Please keep the Cama Beach experience alive for another generation. I've never seen a place that does so many people so much good year after year. ²

I am writing with concerns about the Cama Beach Cabins, etc. facing a potential permanent closure. While I understand that there are some challenges involved in keeping the cabins open, my hope is that those challenges and ways in which they can be overcome, will be very thoughtfully and extensively considered. I was born in Everett, WA forty-six years ago. While I've lived elsewhere (Santa Barbara, CA and Hilo, HI) at times in my life, I am now living in Everett and have for most of my life. Cama Beach is one of the local spots my family has visited on numerous occasions on day trips. However, my fondest memories are related to the time we've spent in the cabins. The Cama Beach Cabins are a nice break from modern times and take one back to a day and age where things weren't so fast paced and technology driven. I feel it's important to sustain places like Cama Beach as there are less and less of them as time progresses. It's important for younger generations to have places they can go to unplug and enjoy the world around them without all of the noise. Cama Beach is unique in this respect due to the rustic cabins that are there. The wooden boat house is a major bonus to the experience as well. My family has loved being able to stay in the cabins and enjoy a rowboat ride and nature right outside our front door. It's also been a treat to walk up for breakfast at the Cafe and order a shaker lemon pie for the road. Additionally, my daughter's girl scout troop has benefited from cabin stays at Cama Beach and Ranger led nature walks. I would be deeply saddened to see such a historic part of Western Washington shut down because of challenges that are difficult but not impossible to overcome. Please do everything you can to keep the Cama Beach Cabins open and available for public use. Respectfully, ³

My family and I have enjoyed Cama Beach Cabins for over 14 years. It has always been a special time with family and friends. We unplug for a long week end, going for hikes, beach comb, and take in every sunrise and sunset. We have been able to watch Eagles fish and seals feeding along the shoreline.

I believe every effort should be made to keep the cabins open for generations to come. This is a unique place and should be preserved. The educational factor is huge for our young children and grand children. Please don't let this extraordinary place go. ⁴

I was surprised and disappointed to see the agency's proposal to turn Cama Beach State Park into a day use park. I believe that would be a mistake.

I looked through the power point presentation of issues. I think those issues were addressed in 2004 when the park was accepted and then developed. Do you believe applicable commission policies and RCWs have changed since 2004?

Of course, there was some soil disturbance when the park was carefully developed. It appears to me, repairs to water and sewer lines in existing trenches would not require disturbing any areas that weren't already disturbed during the park's development. Even if you turn the park into a day use park, the existing central restroom and sewerage system will still need to handle the sanitary needs of large groups of day users. That will

require a sewerage system that is equal to, or exceed, what is presently provided for the cabins.

Certainly, climate change and sea rise were known factors when the park was developed. Removing the cabins now would certainly lead to new soil disturbance. Has the agency investigated raising the foundations to minimize damage from King Tide events?

The sea wall is long. Is it necessary to replace the entire wall? Areas along a seashore are continually evolving. Is there really any danger of disturbing cultural artifacts on the beach? Could the seawall, in places it is failing, be protected with rock gabions or even logs as I've seen, in my lifetime, along the Salish Sea shore?

I appreciate the work the agency does to protect historical artifacts and areas. As a society I believe we do that today when we move graves in graveyards for public works. Traveling through Europe and Asia I've seen how, as the world's population has grown, many of our ancestor's homes, cities and graves have been covered. If we prohibited any activities that might infringe on cultural or traditional sites we would not have the cities and homes that house our world. We would not have many of our parks and we would not even be allowed to climb mountains such as Everest or Denali.

The challenge of Cama Beach is certainly formidable. Please do not give up. Cama gives families a unique opportunity to build their own traditions with an overnight experience along the Salish Sea. You have an opportunity to preserve Cama Beach as a full use state park for **everyone** in Washington. Please do so. Thank you, ⁵

Please prioritize and sustain the efforts to work with the Tulalip tribe in planning a future for Cama Beach Historical State Park. The cabins and resort were built in the 1930's on top of sacred burial grounds, and there is an opportunity to help protect this place and restore cultural humility for land and people since well before 2005, which is when human remains were archaeologically documented. ⁶

Thank you to the Park commissioner present at the July information meeeting. During my last visit to Cama Beach State Park, I was pleased to see several portable restrooms in place at the lower level of the park.

As far as the future of the park and cabins, it would be wonderful in ALL the issues with reopening the cabin be made public, as well as any associated costs to fix. If there are new issues that were not identified in the July presentation, they should be shared with the public. Let's be transparent and share what is known ahead of a time when a final decision is made. If that is done, perhaps we will all come to the same conclusion. ⁷

My vote is to fix that sea wall and upgrade whatever needs to be done to save the cabins. It's a fun, historic step back in time and well used and well loved.

We also did a pergola repair estimated at \$1200 for \$100 using volunteers. Put ou the word thru your website with a date and time, and invite the local tv outlet to the event, and you will be surprised how people will come together if you have a plan. Even if you do one cabin, it will make a difference and get the ball rolling. ¹³

I saw on King 5 that the previously temporary closure of the Cama Beach State Park Cabins might become permanent due to the expense and effort involved in maintaining them.

My family and I only got to stay in the cabins once (due to their popularity!), but it was a wonderful December 2020 visit when many things were closed. Staying in a historic cabin right on the beach was the perfect way to bring some of nature's peace during a challenging pandemic.

We've stayed in many of the state park's cabins and appreciated that Cama Beach had a few more amenities to offer (including a fridge & sink, a separate bedroom for parents). It also already has great support infrastructure for families with the Cama Beach Cafe, Center for Wooden Boats, the little store and the playground and giant chess set. The close proximity to Seattle (90 min or less, no ferry required!) also makes it an easier stay for families with young children who can't drive far.

Roofed accommodations like those at Cama Beach are so helpful to families who don't have all the gear/expertise for tent camping, but might not be able to afford a fancier hotel room. They give us immersive access to special places like Cama Beach, inspiring future generations to protect them. And yet, there aren't enough! Reserving cabins at our state parks is a competitive process with most reservations snatched up months in advance. Removing 33 cabins from the reservable population worsens the issue and takes away from the ability to experience these historic gems.

I recommend that whatever money is required to get Cama Beach opened up again should be spent. This is a very special beach and very unique for us. Residence of Camano Island and visitors.10 ¹⁴⁷

My wife and I firmly support spending the money to do what needs to be done to preserve and use these cabins. They are a priceless asset for people now and for generations to come. I acknowledge the challenges that park staff are faced with.

However, I don't believe the value of the historic structures and the value that they provide to WA State is being sufficiently valued. This does not need to be an "all or nothing" decision. The boat house could be removed if the sprinkler repair can't be completed while leaving the cabins. If the issue with the pumps is electric, that does not sound like a fix requiring substantial ground disturbance. I'm unclear about the projected sea level rise, but there are other cabins (e.g. the Tolt Mcdonald in the King County park system) that are closed seasonally due to flooding and an assessment should be completed about ALL of the mitigation options. Mitigation could include temporary closure of the cabins, lifting them off the ground by 18" etc.

In the event that the WA State parks does move to remove the cabins I hope that they are

offered to willing takers for \$1 so the structures could be reused and preserved in another location. However, I think the preferred option should be to find a way to keep the cabins in place for another +30 years. ¹⁴⁹
