<u>Westport Light State Park – Westport Golf LLC Proposal Comments</u> January 31, 2023 – March 20, 2023

Please do not allow a golf course or any new commercial type
development in the park. It is too valuable as a natural space.
I have been coming to Westport since I was 6 months old and
lived there for 11 years in the 80's. I still come at least once a
year. I come for the natural beach. Please do not allow a golf
course to be developed.
Thank you for listening. ¹
I find it appalling that the state is considering a golf course
development at Westport Light. This is a precious natural area,
with the only no-cars beach in the state. Moneyed interests drive
far too many issues in Washington please don't let this be one
of them! ²
Washington State needs to do more to provide free access to our
coasts and protections for coastal habitats. Building a golf course
on coastal public lands does nothing but remove access for the
majority of the population that can't afford to play golf or who
don't play golf to begin with. Golf as an industry has been
declining with a slight temporary bump during the pandemic.
Most households cannot afford a round of golf but they can afford
to use free trails for walking and biking. I have played golf for
years but as water becomes a more scarce resource worldwide,
golf courses should not be something that we use state green
space for. In addition, golf prices have continued to creep ever
higher at courses causing me to divert my time and dollars spent
to other outdoor activities. Cost to benefit ratio says that a golf
course doesn't provide the best benefit of state land. ³
Westport Light State Park beaches could have sprung from a
novel. Tall dune grasses whisper in the wind. Pathways snake
along low bluffs down to sandy stretches of shore. Sunlight plays
on the landscape (or storm clouds roll in) and birds cry in the
distance."
This park is itself unique and the only beach without vehicular
travel on the sand.
I understand that the Parks Commissioners have a Memorandum
of Understanding (MOU) with a developer that wants to install a
Scottish-style golf course in this park. This will destroy habitat, create noise, and disrupt the animals
and birds that call this park home. It will destroy what makes this
park unique. As well, it will privatize a pristine beach and limit
access to the entire area.
Golf courses are a climate nightmare. They use pesticides. They
use motorized vehicles. They need a great deal of water to
simply exist as a lavish misuse the land for the enjoyment of a
few people involved in a dying sport.
Golf courses are also often the first step towards further
development. They need a club house, a bar, an outside seating
areathe list goes on. As well, houses are the next step, since
the land has already been reshaped and plant with a huge
unsustainable lawn.
Stop this proposed project the destroys land and access. It is a
clear misuse of public land and goes against climate science in
every possible way. It is a bad plan based on a bad idea of what
public land should be used for. ⁴
I think the idea of a fancy golf course at Westport Lighthouse SP
is a travesty. It's such a gorgeous area, and the impact of all the

place should not happen. We could build 50 new golf courses

The land in question at Westport was purchased with State Recreation and Conservation money.
Recreation and Conservation. Taxpayer money, not private development funds. And then to consider
turning the space into a golf course? Are these developers proposing an appropriate use for public
coastal recreation? With public access to the shoreline vanishing is it appropriate to turn something
rare into a private playgound? With all that is known about the damaging environmental effects of golf
courses there is no way the owners can guarantee protection of the water quality, any coastal
wetlands, or migratory species from harm. Wild, open land does not have to be developed, especially
not for an exclusive, expensive sport like golf.

I am writing about the recent news about Westport Light State
Park in Westport. I am appalled that developers want to build a
golf course at this location. The Westport Light State Park is the
only park without vehicle access on the beach. I have visited the
park several years ago and found it to be a beautiful beach with
outstanding sunset and sunset views of the ocean. I especially
would like to save the park from development for it's wilderness
value for wildlife and wildlife connectivity.
I have concerns about erosion and sea level rise along the coast.
In watching your recorded meeting of December 8, 2022, it was
mentioned that hydrologists were considering the impact of 100
year impacts of sea level rise and climate change. Recent research from NOAA and NASA using new
satellite data and
climate models along with improved evaluations of historic data
from tide gauges dating back more than 100 years indicates that
Americans, on average, can expect sea levels on their coasts to
climb 10 to 12 inches in the next thirty years and 2 feet by the
end of the century. These are conservative estimates, according
to the researchers. "A profound increase in coastal flooding with
storms or heavy rainfall with high tide flooding" is to be expected,
according to Nicole LeBoeuf, director of NOAA's National Ocean

report.html Furthermore, along some coasts, natural
features like dunes and marshes may be holding back the sea a
bit, but once the sea rises about those berms, it can spread
inland. Hydrologists need to consider the impact of 500 year sea
level rise, as opposed to only 100 year level rises in considering
the feasibility of this huge economic project. It would be
devastating for the community of Westport to lose the parcel of
land on which the proposed site stands.
Another of my concerns is related to the use of the golf course
during winter months. I spent 3 years living in Long Beach,
Washington and golfed regularly at a par 3 course on the
peninsula. I agree that golfing was and is a great sport with many
benefits; however, I would like to know how many golfers,
especially women and minorities actually golf in rainy, cold, and
wet winters along the coast. I rarely would golf during these times
when I resided along the coast. I doubt that it would get much
use during the November through March months.
The idea of erosion was introduced at the public meeting and the
concern is valid. Taking out trees which may block golf shots will
increase erosion and continued flooding during spring times.
Furthermore, the driftwood which is increasingly sparce along the

beach and dunes area creates habitat for species like sand fleas and other arthropods which are important food for fishes, cetaceans, shore birds, and shrimp. Removing driftwood impacts an entire ecosystem and should not be permitted. The Golf Links project is a huge economic undertaking for the community which would be devastating if lost due to the aforementioned reasons. I strongly oppose the project and recommend permitting not be approved. Thank you for the opportunity to comment.⁷

I am vehemently opposed to the proposed development of a golf course at Westport Lighthouse State Park! In this day and age, when our wild and pristine environments are rapidly disappearing, it seems absurd to consider commercial development of this publicly-owned park that is famous for its natural beauty. Please consider the idea of developing a Scottish golf park in a Washington State Park to be absurd and totally inappropriate in an area that should be protected for its natural values. The shoreline and wetland resources in this park should not be compromised by such a development. Thank you for considering (and hopefully saying no) this request. ¹²
I am opposed to the creation of any type of golf course anywhere in Westport Light State Park. This park is too valuable for wildlife to be given over to golf. Any money spent on this park should be used to restore the land and wetlands by following the recommendations (page 24) of the September 2021 Wildlife Habitat Assessment as prepared by JD Brooks, biologist and Glen Mejia, senior wildlife biologist. ¹³

Please keep the area in its natural state. There are other golf courses for the few who engage in golf. Also, I hear the number of golfers is dwindling. ¹⁵ We need more open spaces in this state, not gold courses. Please do not allow a Scottish gold course at Westport. ¹⁶
As an avid birder of Washington state and one especially draw to our shorebirds and oceanic species I must speak out again the proposal of building a "Scottish style" golf course at the Westport Light state Park. This area is an important coastline and wetland area important to resident and migrational birds. There is a strong draw to this area for birders as well, many of us making trips from other parts of the state to enjoy a rare stretch of public coastline in an otherwise privatized coastal state. This area is also more readily accessible to a larger group of able bodied and monetarily constrained folks than other public land seen further up our coastline. In addition to this well established birding area and public use space, the installation of a water hungry golf course is vastly in opposition to climate change adaptation goals our state should be striving towards. Now is the time to be protecting our wetlands and coasts to ensure a more robust response to our changing climate and the installation of a fresh water draw is a gross misuse of our resources. in finality, please, consider the magnitude of import of this area beyond the prospect of a commercial option limiting use and benefit to those in ownership and with the privilege to access a paid "amenity" in our already wonderful public area. ¹⁷

Below are some of the issues, objections and concerns FOGH has with reference to the proposed conversion of an important and rare interdunal wetland mosaic. These comments are preliminary and we will need to expand those once the SEPA process begins, as there is not adequate information about the layout and operation of the proposed course and amenities. We incorporate by reference comments made by Twin Harbors Waterkeeper, Citizens for a Clean Harbor, Grays Harbor Audubon, Surfrider Foundation. • The project is proposed in an area threatened by coastal erosion. Millions of dollars have already been spent to repair a breach at the Jetty and northern tip of the proposed project. On the southern end of the ocean side of the project. Westport by the Sea Condominiums have also be allowed to "hardened" the shoreline in order to temporarily hold back the erosive forces. • The Department of Ecology conducted the most recent study of coastal sand dunes in Washington in 1974. The Coastal Sand Dune study found that as of 1974 there remained only nine undeveloped sand dune areas in Washington. The sand dune area on the project site and extending to Westport Light State Park was among the largest. Ruef, Coastal Sand Dune Study, Pacific and Grays Harbor Counties, Washington, 1974, Washington Department of Ecology. The Sand Dune Study recognized how valuable and rare this ecosystem is. Of the 2,300 miles of saltwater shoreline in Washington, as of 1974 there remained only 12.5 miles of undeveloped dunal areas. Id. p. 22, 27. The Study found: ... within the total expanses of the dune masses only nine coherent areas of notable size were left in an undisturbed, pristine condition. However, continued pressure from adjacent new developments and rising demands

from the private and public sectors are likely to reduce their integrity to a point beyond which these areas are no longer capable to maintain their natural structure and characteristics. Coastal Dune Study, at 21-22. Particular attentions should be paid to the remaining natural areas and their preservation. They constitute limited natural resources and only collectively these key areas are representative of the unequaled biophysical systems and aesthetics of the dune landscape. Coastal Dune Study, at 28. The Study recommended that "all responsible authorities coordinate their efforts and undertake appropriate steps to protect the previously identified natural areas to the fullest extent possible. Until their status has been defined and suitable boundaries and management concepts have been formulated, local governments should place a moratorium on substantial development of and physical alteration in those areas." Id.

• The subject property is an Aquatic Resource of National Significance (ARNI) on a shoreline of statewide significance. The

project would destroy the largest undeveloped interdunal wetland system in the region. It is especially fragile because it is bordered by state parks and public recreation lands. While the wetlands to be impacted is an Aquatic Resource of National Significance (ARNI), the proposal is for a private non-water dependent use.

• There doesn't seem to be recognition of off-site connections between the mosaic of wetlands that characterize the interdunal wetlands. The applicant significantly undervalued and undercounted the wetlands that would be impacted. It did this by using incorrect delineation methodology, by delineated connected wetlands as separate, and by ignoring off-site connections between the wetlands.

• The wetland system's value is increased because the system at present is largely in public hands and because it provides an integral backdrop for State Parks.

• The previous golf proposal, known as "Links at Half Moon Bay" dug detention ponds which effectively and illegally de-watered nearby wetlands. How will this degradation be mitigated and/or restored?

• Fertilizers, herbicides and pesticides will be applied to certain areas of this mosaic, including the greens. Despite the fragile ecosystem there doesn't appear to be any treatment system. Runoff, containing pesticides, fertilizers, and herbicides will enter an extremely fragile portion of the Grays Harbor Estuary, and seep to the ocean shoreline.

• Visitation to Westhaven in the past was over 1 million annually, until the discovery pass requirement limited some public from utilizing this public resource. How will the further restrictions of privatization of public lands impact visitors?

• The introduction of the golf course into upland areas will limit if not prevent restoration opportunities to those areas, and the runoff of herbicides, pesticides and fertilizers may negatively impact adjacent wetland communities.

• The introduction of herbicides, pesticides, and fertilizers may impact ground water and carry these pollutants to the north and center wells.

• According to HUD 2019 LMI, as reported in the Washington Parks 2023 – 2025 Budget Request the City of Westport has a community with approximately 60% of the population having a low to moderate income level. With regard to equity, the budget proposal stated as follows: "Parks need to be accessible and welcoming to everyone, and the agency is committed to creating a hospitable, safe, and inclusive park environment.

The pandemic events of 2020 highlight the importance of state park's role in supporting physical and mental wellbeing, regardless of race, identity, abilities, or socioeconomic status. All resource requests to pay for improving the park system would contribute to State Parks success. This includes ensuring that all visitors are welcome and have access to a well -run park system that meets their expectations." (State Parks and Recreation Commission Capital Project Request, page 443, item 11)

Comments Re: Proposed golf course at Westport Light State Park
I would strongly encourage the city of Westport to abandon this plan
to turn the park into a golf course. I travel from Olympia to Westport
approximately monthly to walk and bird on the trails and beaches
there, eat some great seafood in town, and take in the beauty of the
park. From what I can see from the proposal, I think a golf course is
likely to have a negative impact environmentally, and is unlikely to
result in the forecasted economic benefits to the city of Westport. All
references are listed below.
1) The golf course will further destroy important habitat for many
species. This is the opposite of the opinion of the WA State Habitat
report, which recommended improving and fostering native species
habitats, with special attention on removing non-native vegetation to
better support the diversity of all the other species at the park. A
golf course not only destroys what's there, it introduces additional
new non-native grasses for fairways and putting greens, along with increased water, fertilizer and pesticides necessary to maintain
them. While there is currently no legacy or old-growth forest, there
is potential for those important and increasingly scarce forested
habitats to develop - IF you don't cut down the trees for a golfcourse.
2) There are many many birds which use that habitat, even as it
exists today, species which can't or won't reside near a golf course.
The WA State Habitat study counted some 100+ bird species they
observed in their limited sample. See the below list in the
references for the eBird Species list for species observed since
2020 at this hotspot, which shows a likely species count closer to
200. This diversity of bird species will be reduced at this location,
with likely impacts to their populations if you replace their current
habitat with a golf course. As you probably know, loss of habitat is a
primary cause of species loss, so maintaining habitat wherever possible is important to their survival.
3) A golf course will not be necessarily result in a 'net gain' of
visitors/tourists to the area. The current visitors who come to this
park, then shop & eat at Westport (like me) because it's not as
commercial as Ocean Shores will simply go elsewhere. There is no
real 'mixed use' scenario from a visitor point of view: Not only will
non-golfing park visitors be excluded from that area of the park,
even the paved trail on the ridge overlooking the beach is unlikely to
be safe from errant golf balls for walkers and hikers (I know this
because I am that kind of golfer, as well as a trail walker).
4) A Golf course may demand more municipal resources than you
expect in day to day operations. Golf courses require a lot of fresh
water – the State of WA hydrology estimate is 500,000 gallons per
day during the dry season. The Hydrology report and the Wetlands
report caution that the risks of pollution (fertilizer and pesticides) if
the course is not designed, built and continuously monitored to

prevent impacts to water quality there could be a very significant degradation of habitat and risk to the water supply.

• Has the city of Westport thought about the added demand on local fresh water sources that a golf course will require, and how it's going to meet that demand (infrastructure)? In municipal volume terms, golf course monthly water use in the summer will be approximately 2,005,000 cubic feet.

• Have the developers committed to making sure the design and ongoing operations (monitoring water levels and quality) to meet all the state of WA hydrology recommendations which should reduce the risk of chemicals/nitrogen leaching into the wetlands and/or polluting the local water sources?

• Has the municipality made plans/budgets to take on the cost of monitoring/regular oversight to ensure those water monitoring commitments will be met going forward?

Given that ongoing environmental monitoring demands and a private entity operating the golf course, does Westport have a risk management plan/insurance/financial commitments in place to deal with the environmental needs if the private operator goes bankrupt? I would think you'd want to ensure it's not 'déjà vu all over again'.
5) Finally, has the city of Westport closely reviewed the economic benefits forecast for this golf course project? This location is windy, frequently VERY windy, rainy and cold except in the summertime. Unless you are willing to golf wearing a parka and mittens, I'd expect that 6-7 months of the year the course is unlikely to be used by golfers. I recommend decision-makers carefully scrutinize these economic promises to see if they're really plausible in light of a limited 6 or 7-month golf season.

Dear Heather,

My name is - and I am a citizen of Westport. Since moving to Westport with my husband about 1.5 yrs ago we have become steadily more involved in the community and have begun to hear more about the proposed plans for the golf course and the both the potential positives and negatives it may have for the community. I received your contact info from -, who said you were the right person to contact regarding public comment.

I am writing to specifically voice my sincere hope that the full length, paved, oceanfront walking path not be altered by the golf course (in the event that it does move forward, which I oppose in general) and remain intact in its current state. Since moving here I have gone for runs back and forth on this path about 3 times per week and have observed its clear value to the community in multiple unique ways over that period.

1. The path builds community - I see and converse with my neighbors on this path multiple times per week and make new friends. The community needs these safe public recreation spaces to interact with one another and build community.

2. The path provides safe, accessible, healthy recreation for children, families, and people of all ages - I see families teaching their children to ride their bikes for the first time, I see teenagers skateboarding, I see people walking their dogs, yesterday I saw three women in their 80's going for a walk together in the sunshine. In a town with few sidewalks, this area is a critical safe space for these activities and brings joy to its residents.

3. The path provides useful edge habitat for animals - The deer and pheasants graze along this path and hawks and bald eagles find it useful for hunting.

4. The path drives tourism - this stunningly beautiful path is an obvious attraction in the town and is the one of the first places I send visitors. It is a key reason to visit westport and has a benefit for tourism.

I firmly believe that a survey of the frequency of path use, and the varied uses of the path, would demonstrate the core value of the path, in its current state, to our community. I am a biological research scientist and have extensive expertise in data gathering and data analysis. I would be happy to aid in setting up an online or in person survey of these uses over the upcoming months. Feel free to call me to set this up.
